7. CONDITION AND MAINTENANCE OF THE POOLS AT MARAIS STREET, RUSTENBURG

1. 50 METER GALA POOL

- 1.1. This pool has recently developed a critical structural crack underneath its tiles and in its concrete sub-structure. This pool needs urgent but costly repairs done to its structure to save the facility.
- 1.2. The starting blocks of this pool are also in need of urgent repairs/replacement.
- 1.3. This pool needs urgent attention to its chlorine gas as well as circulation equipment (pump house).
- 1.4. To accommodate provincial and national gala events the spotlight system also needs to be repaired and upgraded.

2. 25 METER DIVING POOL

- 2.1. This pool needs costly repairs to its circulation equipment (pump house) as well as to the underwater pool surface.
- 2.2. Month to month maintenance of the mechanical equipment was mostly done by Rustenburg Swimming Club during the last 6 (six) months and at the expense of RSC.

3. CHANGING ROOMS AND TOILETS

3.1. Only needs minor repairs.

4. HARRY WULFSE HALL

This hall needs costly repairs to its rotten and broken wooden floor.

5. FUTURE MAINTENANCE

All facilities at THE POOL premises require fixed monthly maintenance, ie chemicals for the PH balance of the water, gardening, cleaning, etc.

6. COSTS OF REPAIRS AND MAINTENANCE

- 6.1 Rustenburg Swimming Club has obtained a quotation for the urgent repairs mentioned in 1 and 2 above, as well as for the fixed monthly maintenance mentioned in 4 above. The quotation is attached hereto as annexure "A".
- 6.2 The urgent outstanding and immediate repairs to the pools amount to R 3 662 338-80 (THREE MILLION SIX HUNDRED AND SIXTY TWO THOUSAND THREE HUNDRED AND THIRTY EIGHT RAND AND EIGHTY CENTS).
- 6.3 The recurring maintenance amounts to R 62 050-00 (SIXTY TWO THOUSAND AND FIFTY RANDS) per month.

9. CASH FLOW AND AFFORDABILITY OF THIS RENTAL TO RUSTENBURG SWIMMING CLUB

Although Rustenburg Swimming Club is a non-profitable sports club, as a 59-year-old prestigious club its finances and cash flow is sound.

As the official registered swimming club of the city of Rustenburg, Rustenburg Swimming Club furthermore receives financial support from both Northwest Swim (NWS), the official swimming governing body of the province of Northwest, as well as from Swim South Africa (SSA), the official National swimming governing body of the Republic of South Africa.

Rustenburg Swimming Club will also generate its own income by the hosting of Local, Provincial as well as National swimming galas.

Rustenburg Swimming Club will furthermore generate a steady stream of income from the entrance fees payable at the gates of the pool facilities.

10. TERM OF RECOVERY OF COSTS

The immediate expenses to the pool facilities is R 3 662 338-80 (THREE MILLION SIX HUNDRED AND SIXTY TWO THOUSAND THREE HUNDRED AND THIRTY EIGHT RAND AND EIGHTY CENTS) as can be seen from page "S", attached hereto, excluding the repairs at the Harry Wulfse Hall.

The fixed monthly maintenance of the facilities is R 62 050-00 (SIXTY TWO THOUSAND AND FIFTY RANDS) as can be seen from annexure "A", attached hereto.

With the huge expenses mentioned above as well as the fact that outdoor swimming is in essence a summer season sport, it is estimated that the recovery time of the mentioned costs will be a long-term project and might easily be in the region of twenty or more years.

It is therefore essential that the rental of THE POOL be awarded to Rustenburg Swimming Club for a long and extended period.

11. OFFER/PROPOSED RENTAL PAYABLE TO THE RLM

Seen in the light that:

- 1. The immediate expense of several millions of rands to this facility is necessary; and
- 2. That the RLM will be absolved from the expense of future monthly maintenance of the sport facility and associated salaries; and
- 3. That the Rustenburg Swimming Club takes full responsibility for the full fixed monthly maintenance cost of the facility; and
- 4. That the Rustenburg Swimming Club takes full responsibility for the cost of repairs of future damages; and
- 5. That the Rustenburg Swimming Club will uplift/upgrade/develop the sports facility to the benefit of the community of the city of Rustenburg, as well as to the benefit of the RLM (as the owner of the sports facility);

- 3. Rustenburg Swimming Club to pay monthly rental of R100 (ONE HUNDRED RAND) to the RLM in lieu of THE POOL; and
- 4. Rustenburg Swimming Club to be absolved from any liability towards the Rustenburg Local Municipality (or any other body) of payment of any water, electricity and other taxes and fees applicable to the POOL facility.

13. PUBLIC LIABILITY INSURANCE

Upon conclusion of a successful rental agreement, the Rustenburg Swimming Club will take out public liability insurance and indemnify the RLM of public liability forthcoming from this Sports Facility.

DETERMINATION OF MARKET RENTAL IN RESPECT OF MARAIS SWIMMING POOL RUSTENBURG – ERF 1488

Your instruction to provide market evidence in respect of property used for sports and recreation facilities refers.

1. Purpose of valuation

To determine a fair and reasonable market related rental and rates for community halls and swimming pools within Rustenburg Local Municipality.

Market related rental rates were obtained from the commercial market in Rustenburg and adjusted according to the location and highest and best use of this properties.

Enquiries and consultations with superintendent of similar facilities in and around neighbouring towns e.g. Brits and Pretoria have indicated the rates as shown in the tables below, moreover In view of information obtained we are of the opinion that a fair and reasonable rates are as follows:

(Collectively the "Parties")

PREAMBLE

WHEREAS the Parties have realized a need to work together for the purpose of developing a co-operative relationship with regard to sport development within the city;

WHEREAS the Parties in compliance with the requirement of intergovernmental framework intends to forge a sustainable working relationship based on co-operative governance;

WHEREAS the Parties shares a mission to build a lasting and beneficial relationship that will enable greater co-operation and sharing of resources for the benefit of both organizations in educational, community and youth development programs; and

WHEREAS the Parties wish to assist each other in trying to improve the lives of the people in its area of jurisdiction.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. PURPOSE AND SCOPE: -

The main purpose and scope of this agreement is to:

- 1.1 Forge a working relationship in mutual trust and good faith facilitating effective and efficient sport development and implementation of swimming programmes;
- 1.2 Foster and maintain a spirit that guides genuine cooperation and mutual support for the benefit of the communities;

2. REPRESENTATIVES OF THE PARTIES

Each party shall appoint a person to serve as the official contact and facilitator for the co-ordination of all the activities to this SLA:

2.1 RUSTENBURG SWIMMING CLUB

Mr Fanie van der Walt in his capacity as the Chairman of the Rustenburg Swimming Club;

And

2.2 RLM

Mr in his capacity as Municipal Manager of Rustenburg Local Municipality

4. DURATION OF THIS AGREEMENT

4.1 The duration of this agreement is for a period of five years from the effective date of this agreement and may be extended upon written mutual agreement by the Parties.

5. GOODFAITH

- 5.1 This SLA is entered by the parties within acceptable norms of intergovernmental relations as dictated by the principles of good faith;
- 5.2 The SLA constitutes the sole record of the agreement between the Parties. Neither Party shall be bound by any express, tacit or implied term, representation, warranty, promise or the like not recorded herein;
- 5.3 No addition to, variation, or agreed cancellation of any provision of this SLA shall be binding upon the Parties unless reduced to writing and signed by the Parties;

6. REVIEW OF AGREEMENT

- 6.1 This agreement may be reviewed or amended by the parties as when necessary. No amendments shall be effected on this SLA except done in writing and signed by all the Parties.
- 6.2 The Parties acknowledge that neither of the Parties has any authority whatsoever to represent or to bind the other Party in any capacity whatsoever. In particular, but without limiting the generality of the foregoing, neither Party shall be entitled to conclude any contract or sign any document on behalf of the other Party, or in any way bind the other Party's performance, variation, release or discharge of any obligation, except where provided for in this SLA.

7. TERMINATION OF AGREEMENT

7.1 Either party may terminate this agreement at any time by giving the other party a period of sixty (60) days written notice.

199. REQUEST COUNCIL APPROVAL FOR FULL OR PARTIAL LEASE AGREEMENT WITH THE RUSTENBURG SWIMMING CLUB

(Directorate: Community Development) 11/1/4/1 (0012475) (LGJ/cb)

1. STRATEGIC THRUST

The Rustenburg Local Municipality has adopted, amongst others, the following key priority areas:

- Efficient provision of quality basic services and infrastructure within a well-planned spatial structure
- Drive diversified economic growth and job creation
- Ensure municipal financial viability and management

2. PURPOSE OF THE REPORT

The purpose of this report is to request Council to approve a service level agreement with the Rustenburg Swimming Club for a period of five years.

3. EXECUTIVE SUMMARY

This item was to serve at the Directorate: Community Development Portfolio Committee of 7 January 2023 which did not quorate, and the decision taken was that the item will serve at the next Mayoral Committee sitting.

The Rustenburg Swimming Club has been in existence for almost sixty (60) years. They are registered with North-West Swimming and Swimming South Africa. They are a non-profitable sport club (Registration details attached as **Annexure A**) teaching swimming from an early age up to National and International swimming gala competitions.

A tender advert was published RLM/DCD/0093/20/21 during June 2020, for interested parties / individuals to submit proposals for the management and maintenance of various sports and recreation facilities which included the Marais Street Swimming Pool. The closing date for submissions was on 05 July 2020. The Rustenburg Swimming Club submitted a proposal, but it was unfortunately declined during the evaluation process due to non-submission of some administration documents.

The Rustenburg Swimming Club submitted another proposal to the Municipality during March 2022 (*Annexure B*), requesting co-management of the Marais Street Swimming Pool. The Marais Street Pool also known as the Town Pool, is the only facility with an Olympic size gala pool which complies to National Swimming Standards in the North-West Province as outlined by Swimming South Africa. The Olympic pool has been out of order for over a year due to a major leak. The Rustenburg Swimming Club has offered support to get the pool repaired by exploring various sponsors and donors. The valuation report of the facility is attached as *Annexure C*.

The Directorate had another discussion with the Swimming Club to present a second option of a partnership agreement and both options are discussed below.

4. Discussion

4.1 Option 1: SLA for a Portion of the Pool Area

--- Service Level Agreement: Annexure D

The option under discussion is to lease a portion of the facility to the Rustenburg Swimming Club. This includes the Olympic pool, clubhouse and adjacent parking bay. This option gives the municipality complete access to the other half of the facility which can be used and enjoyed by the public. This option will also present an opportunity for other swimmers from other clubs to partner with the Rustenburg Swimming Club in using this facility.

The Club will also be responsible for all the repairs and maintenance of the portion allocated to them including payment of a pre-determined monthly rate, municipal services and waiving of monthly rental fees in lieu of maintenance undertaken on the municipal infrastructure.

There will be a separate entrance gate controlled by the club's own security. They will collect entrance fees from patrons accessing and utilising the portion allocated to them and will take full responsibility of their safety. The club will also expand services at the facility by including underwater hockey, splash polo and water aerobics and undertaking internal company adverts as a fundraising option.

4.2 Option 2: SLA for the Entire Facility

The Rustenburg Swimming Club first preference is to have a lease agreement for the entire swimming pool facility situated at Marais Street. This includes the Olympic pool, diving pool, baby pool, club house and parking areas. The Olympic pool is currently out of order due to a major water leak, and it also requires new grouting of the entire bath tiles.

To ensure that the needs of the Community are not compromised and due to the valuation amount on the Pool, the Directorate is of the opinion that this option is not preferable as it might be unaffordable for the Club.

The Club, with option 2, will be responsible for all repairs and maintenance, they will pay a valuation determined monthly rental fee and pay for municipal services. In order to sustain themselves they will in return collect gate takings and funds generated through competitions and swimming gala's. They will expand services at the facility by including underwater hockey, splash polo and water aerobics. With this option the current RLM workforce at this pool will have to be transferred to other pools within the Municipality.

5. FINANCIAL COMMENTS

In terms of the Municipal Finance Management Act no 56 of 2003, Section 15, a Municipality may incur expenditure only in terms of an approved budget.

The Swimming Pools Section for the current financial year, has an amount of 403 321 for maintenance of all the municipal pools. These funds are to cater for repairs and

maintenance at all the municipal swimming pools. The operational expenses have always exceeded the revenue collected. We therefore as an alternative, must explore alternative ways of uplifting our facilities and ensuring that it remains accessible to the communities.

According to the 2021/2022 Asset register, the whole Marais Pool complex is valued at R 2.6 million having been acquired at R8.4 million.

The Municipality strives for efficient provision of quality basic services and infrastructure within a well-planned spatial structure with the objective to improve public amenities and good governance. Due to budget constraints, the MOU will see to it that the swimming pool is adequately serviced and thus continues to provide services to the community at large. A partnership with the Club will relief the municipality financially of the responsibility of maintaining full or part of the facility.

6. <u>LEGAL COMMENTS</u>

Consideration should be made in terms of sub-regulation 34(1) of the Municipal Asset Transfer Regulations (MATR) which stipulates that the Municipality may grant a right to use, control or manage a capital asset only after the Accounting Officer has conducted a public participation process regarding the proposed granting of right and the municipal council has in principle, approved that the right be granted.

It is also important to establish both the **duration** of the proposed right and the **value** of the capital asset, as the municipal council ought to determine if the public participation process should be followed or not, as prescribed in sub regulation 34(2) Municipal Asset Transfer Regulations (MATR).

Subject to the above, sub regulation 34(3(b), provides that at an instance where the request for the public participation process is made to the council, such request should be accompanied by the statement asserting the reasons for the proposal to grant such a right; any expected benefits to the municipality arising from granting of such a right; any expected proceeds to be received by the municipality from granting such a right; and any expected gain or loss that will be realised or incurred by the municipality arising from the granting of such a right.

7. CONCLUSION

We welcome the proposal from the Rustenburg Swimming Club and the interest shown by them to uplift and co-manage the Town Pool. Their objective is in line with our objective, which is to renovate the facility and to create a safe place for its users and the community. We therefore present these options for consideration by Council.

7. CONDITION AND MAINTENANCE OF THE POOLS AT MARAIS STREET, RUSTENBURG

1. 50 METER GALA POOL

- 1.1. This pool has recently developed a critical structural crack underneath its tiles and in its concrete sub-structure. This pool needs urgent but costly repairs done to its structure to save the facility.
- 1.2. The starting blocks of this pool are also in need of urgent repairs/replacement.
- 1.3. This pool needs urgent attention to its chlorine gas as well as circulation equipment (pump house).
- 1.4. To accommodate provincial and national gala events the spotlight system also needs to be repaired and upgraded.

2. 25 METER DIVING POOL

- 2.1. This pool needs costly repairs to its circulation equipment (pump house) as well as to the underwater pool surface.
- 2.2. Month to month maintenance of the mechanical equipment was mostly done by Rustenburg Swimming Club during the last 6 (six) months and at the expense of RSC.

10. TERM OF RECOVERY OF COSTS

(Herein represented by in his capacity as Municipal Manager, duly authorized hereto

(RLM)

AND

THE RUSTENBURG SWIMMING CLUB

(Herein represented by Mr Fanie van der Walt in his capacity as Chairman, duly authorized hereto

(RSC)

(Collectively the "Parties")

PREAMBLE

WHEREAS the Parties have realized a need to work together for the purpose of developing a co-operative relationship with regard to sport development within the city;

WHEREAS the Parties in compliance with the requirement of intergovernmental framework intends to forge a sustainable working relationship based on co-operative governance;

WHEREAS the Parties shares a mission to build a lasting and beneficial relationship that will enable greater co-operation and sharing of resources for the benefit of both organizations in educational, community and youth development programs; and

WHEREAS the Parties wish to assist each other in trying to improve the lives of the people in its area of jurisdiction.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. PURPOSE AND SCOPE: -

The main purpose and scope of this agreement is to:

- 1.1 Forge a working relationship in mutual trust and good faith facilitating effective and efficient sport development and implementation of swimming programmes;
- 1.2 Foster and maintain a spirit that guides genuine cooperation and mutual support for the benefit of the communities;

2. REPRESENTATIVES OF THE PARTIES

Each party shall appoint a person to serve as the official contact and facilitator for the co-ordination of all the activities to this SLA:

2.1 RUSTENBURG SWIMMING CLUB

Mr Fanie van der Walt in his capacity as the Chairman of the Rustenburg Swimming Club;

And

2.2 RLM

Mr in his capacity as Municipal Manager of Rustenburg Local Municipality

3. RESPONSIBILITIES OF PARTIES

3.1 RUSTENBURG SWIMMING CLUB

The Club shall:-

- 3.1.1 Renovate and maintain the Olympic pool as agreed by both Parties;
- 3.1.2 Pay for municipal services;
- 3.1.3 Pay monthly rental fees;
- 3.1.4 To take responsibility for their own costs resulting from the implementation of this agreement;
- 3.1.5 Provide security to safeguard the well being of their employees, clients, physical resources and equipment;
- 3.1.6 Allow access to the general public as and when required during normal operating hours;
- 3.1.7 Develop and implement programmes and utilization schedules
- 3.1.8 Ensure regular updating to RLM on new developments and programmes that are taking place at the facility;
- 3.1.9 Submit quarterly reports outlining the activities, progress and challenges;
- 3.1.10 Assist RLM when required and requested by RLM; with programmes aimed at RLM staff development and capacity building; subject to the Supply Chain Policy and legislation of RLM;
- 3.1.11 Share and or exchange any information that may be relevant towards the successfulness of this SLA.

3.2 RUSTENBURG LOCAL MUNICIPALITY

The Municipality shall:-

- 3.2.1 Maintain the facility in accordance to budget provision and as may be agreed between the Parties from time to time;
- 3.2.2 Waive rental fees equivalent to the expenses incurred by the Lessor for renovations and repairs:
- 3.2.3 Provide access to the Clubhouse (or any other infrastructure space as agreed to by both Parties); to ensure day-to-day working environment that is compliant with Health and Safety regulations;
- 3.2.4 Where necessary, identify and extend invitation to other service providers to implement additional swimming and sports programmes including upliftment and promotion of the facility, as may be agreed between the Parties from time to time;
- 3.2.5 Inform the Rustenburg Swimming Club of any new community development programmes relevant to this agreement and of its IDP and other Projects as approved by the Council of the Rustenburg Local Municipality
- 3.2.6 Ensure coordination between all stakeholders including sports councils, sports forums and municipal departments;
- 3.2.7 Record and report events and programmes to all stakeholders;
- 3.2.8 Jointly assist and consult with all stakeholders to provide information as and when required;
- 3.2.9 Assist with access to facilities owned by the municipality for joint programmes;

4. DURATION OF THIS AGREEMENT

4.1 The duration of this agreement is for a period of five years from the effective date of this agreement and may be extended upon written mutual agreement by the Parties.

5. GOODFAITH

- 5.1 This SLA is entered by the parties within acceptable norms of intergovernmental relations as dictated by the principles of good faith;
- 5.2 The SLA constitutes the sole record of the agreement between the Parties. Neither Party shall be bound by any express, tacit or implied term, representation, warranty, promise or the like not recorded herein;
- 5.3 No addition to, variation, or agreed cancellation of any provision of this SLA shall be binding upon the Parties unless reduced to writing and signed by the Parties;

6. REVIEW OF AGREEMENT

- 6.1 This agreement may be reviewed or amended by the parties as when necessary. No amendments shall be effected on this SLA except done in writing and signed by all the Parties.
- 6.2 The Parties acknowledge that neither of the Parties has any authority whatsoever to represent or to bind the other Party in any capacity whatsoever. In particular, but without limiting the generality of the foregoing, neither Party shall be entitled to conclude any contract or sign any document on behalf of the other Party, or in any way bind the other Party's performance, variation, release or discharge of any obligation, except where provided for in this SLA.

7. TERMINATION OF AGREEMENT

7.1 Either party may terminate this agreement at any time by giving the other party a period of sixty (60) days written notice.
