PUBLIC PARTICIPATION ON THE DRAFT MUNICIPAL BY-LAW AND POLICY

The Rustenburg Local Municipality hereby gives a notice in terms of Section 18 of the Local Government Municipal Systems Act (32 of 2000). This notice serves to invite all the Rustenburg Local Municipality residents to participate by commenting on the following Policy and Draft Municipal By-Law as subjected by the council on its meeting held on the 21st September 2023 and 25th September 2024 respectively.

1. PARTIAL LEASE AGREEMENT WITH THE RUSTENBURG SWIMMING CLUB
2. DRAFT REVIEW OF THE RULES OF ORDER BY-LAW

The Municipality will be expecting the written submissions on the above stated by-law and policy on or before the 19th March 2025.
