PUBLIC NOTICE

WATER SUPPLY INTERRUPTION

Magalies Water, our main bulk water supplier, that supplies water to parts of Rustenburg, have communicated with the Municipality of forthcoming water supply interruptions

Residents and Businesses within the Rustenburg Local Municipality, who are supplied by Magalies Water (Vaalkop System) will unfortunately be affected by these water interruptions. The Vaalkop dam is currently at low levels of about 23%.

This current situation is intensified by underwhelming rainfall cycles, unwavering heatwave in the region and degradation of raw water quality in the catchment due to pollution, which has also affected Magalies Water's ability to produce demanded water volumes for potable use by bulk customers.
