

JST appeals to community to help reunite families with loved ones who have passed on

This week, Job Shimankana Tabane Hospital (JSTH) has made a heartfelt appeal to the public, asking for help in tracing the families and next of kin of patients who sadly passed away while under its care. According to a media release issued on 5 January 2026, the hospital is seeking assistance from community members, neighbours, churches, civic organisations, and anyone who may have information that could help reconnect families with their loved ones who have died.

The hospital has released the names of the deceased patients whose next of kin have not yet been located. They include:

If a job asks for your wallet, WALK AWAY!

Platinum Weekly newspaper | Rustenburg – Residents of Rustenburg are being urged to stay alert after a surge of fake job offers began circulating on social media and community WhatsApp groups.

According to a notice issued by the Rustenburg Local Municipality's communications unit on 8 January 2026, fraudsters are falsely claiming to offer employment opportunities within Rustenburg Local Municipality. These messages often look convincing, but their goal is simple: to trick job seekers into handing over money or personal information.

The municipality has made it clear that no legitimate municipal job offer will ever require payment, banking details, or personal documents such as ID copies as a condition for employment. Any message asking for these details in exchange for a job should immediately raise red flags.

REMEMBER!

- Verify job opportunities only through the official Rustenburg Local Municipality website or by contacting the municipality directly.
- Ignore and deleting messages or calls that ask for money, banking details, or personal information related to job offers.
- Report suspicious messages to the South African Police Service (SAPS) and to the municipality.

As unemployment continues to place pressure on many households, scammers often prey on hope and urgency. Do not fall victim to employment scams.

Groceries stolen, seven arrested as police recover hijacked vehicle



Platinum Weekly newspaper | Rustenburg – Seven suspects were arrested and stolen property recovered following a police operation in the Bojanala Platinum area late last month. On 27 December 2025, members of the South African Police Service attached to Boitekong and Tlhabane Visible Policing, the Crime Combating Unit, and the Phokeng K9 Unit acted on information that led them to the R510. There, police stopped a hijacked motor vehicle that was being towed and accompanied by two other vehicles.

According to warrant officer Ofentse Mokgadi, further investigation led officers to Tshenolo New Stand, where groceries believed to be stolen were recovered. The goods were valued at approximately R9,000. Seven suspects were taken into custody in connection with the incident. They appeared before the Rustenburg Magistrate's Court on 30 December 2025, where the matter was postponed. The suspects were remanded in custody and are expected to return to court on 21 January 2026.
