The Rustenburg Local Municipality (hereafter "the RLM") intends to close and rehabilitate the Townlands site (hereafter "Townlands Landfill Site") with approximately 1 650 000m³ of waste in place from the natural ground level on properties measuring approximately 10 hectares in total, situated on remainder of Portion 1 of the Farm Townlands 272 – JQ, commonly known as Sondela dumping site; which is owed by RLM.

The Townlands Landfill was established on the remainder of Portion 1 of the Farm Townlands 272 – JQ in the Rustenburg Municipality Area, and is located approximately 3.5km to the north of the town of Rustenburg. Access to the site is via the Thabazimbi Road; an asphalt service road dedicated to the landfill site and a crusher plant is located to the south of the site.

The RLM will follow a two – stage process to identify a private party to collaborate in an attempt to undertake the closure and rehabilitation process. The process to identify a suitably qualified and experienced private party will be subject to a comprehensive written agreement being entered into between the RLM and the successful private party, thereby obliging the successful private party to undertake the closure and rehabilitation in accordance with the agreements as entered into with the RLM.

The first stage of this two – stage process consists of this invitation to suitably qualified and experienced private parties interested in undertaking the closure and rehabilitation to submit a conceptual programme with specific activities and timelines. The proposed closure and rehabilitation should be supported by risk assessment report study undertaken at risk by the private party.

The proposed programme of activities also includes the impact, benefit and other spin-offs (including number of jobs to be created, etc) to be leveraged from the immediate community.

The RLM will evaluate all proposals received, thereafter the RLM will invite those private parties whose proposal programme are, within the discretion of the RLM, deemed suitable, to submit detailed specifications and priced proposals in accordance with their proposed programme for evaluation and adjudication.

The project will be undertaken at no cost to the municipality

The RLM reserves the right to reject all proposals if none are deemed suitable. The RLM also reserves the right to call a private party to provide further details or information and to make a presentation at a time convenient to the RLM.

A private party whose closure and rehabilitation concepts are deemed suitable will be notified in writing and invited to submit, *Inter alia*, their final and priced proposals in accordance with their conceptual proposals for the Closure and Rehabilitation. The invitation to submit final proposals will contain additional conditions and requirements identified by the RLM following consideration of the initial conceptual plan. The RLM again reserves the right during this second stage of the process to reject all proposals if none are deemed suitable.
