1. OPENING PRAYER AND WELCOME:

1.1 The meeting was opened with a prayer by Cllr Snyders L B, where-after the Honourable Speaker welcomed all members present.

2. APPLICATIONS FOR LEAVE OF ABSENCE:

2.1 That leave of absence be granted to the following Councillors: Cllr Nke H S R R, Cllr Mabe L L, Cllr Coetzee M, Cllr Dumani M C, Cllr Petlele S P, Cllr Mooketsi T Z and Cllr Qobeka J (Arrived);

2.1.1 It be noted that the following Councillors requested to be recused: Cllr Bridger A T at 15:00, Cllr Keyser 15:00, Cllr Mokapi C T at 13:00, Cllr Myoli V at 17:00 and Cllr Rothman T at 14:30;

2.1.2 It be noted that the following Councillors will arrive late: Cllr Edwards I (Arrived) Cllr Mokgatle O (Arrived), Cllr Pooe M M (Arrived), Cllr Rangwaga M J (Did not arrive), Mokapi C T (Arrived), Cllr Matjene T E (arrived) and Cllr Gumede J I (Arrived);

2.1.3 It be noted that Council approved the prolonged maternity leave for Cllr Letlape S starting from the month of July 2022, for a period of six (6) months.

2.2 NOMINATION OF THE ACTING SINGLE WHIP

2.2.1 Cllr du Plessis G J nominated Cllr Nhacaungue N, seconded by Cllr Snyders L B;

2.2.2 It be noted that Cllr Nhacaungue N accepted the nomination;

2.2.3 Cllr Pule L J nominated Serongoane P H, seconded by Sethonga D M;

2.2.4 It be noted that Cllr Serongoane P H declined the nomination;

2.2.5 Cllr Rampou's nomination was declined as he is the sitting member of the Mayoral Committee;

2.2.6 Cllr Rampou T nominated Cllr Moatshe F, seconded by Cllr Marekoa B B;

2.2.7 It be noted that Cllr Moatshe F accepted that nomination;

2.2.8 It be noted that during the voting process for the Acting Single Whip by show of hands, sitting members of Council were 67 and the results are as follows:

- Absent - 0;
- Cllr Nhacaungue N received 33 votes;
- Cllr Moatshe F received 34 votes;

- 2.2.9 It be noted that after the results were read out the Speaker congratulated Cllr Moatshe F on his appointment as Acting Single Whip;
- 2.3 It be noted Tsogang Civic Movement requested a five (5) minutes caucus which the Speaker granted.

- That Council sitting be postponed because the reports that were supposed to form part of the agenda according the resolutions taken on the 26th July 2022 are not included in the agenda;
- 2.3 It be noted that the Speaker ordered Cllr Mokgathe O and Cllr Mokgosi T C to leave the Chamber for 30 minutes as they were interjecting the Speaker's submissions and that they refused to leave;
- 2.4 It be noted that the Speaker ordered the Sergeant-at-Arms to assist in removing Cllr Mokgatle O, Cllr Mokgosi T C and Manyaku E S in line with Rule 85(4) of the Rules of Order By-Law;
- 2.5 It be noted that Council was adjourned for fifteen (15) minutes to allow the Sergeant-at-Arms time to remove Councillors mentioned above from the Council Chamber;
- 2.6 It be noted that the Councillors of the Economic Freedom Fighters and Tsogang Civic Movement walked out;
- 2.7 It be noted that after both parties left the Council Chamber the Speaker requested a five (5) minutes break to check if the meeting quorate;
- 2.8 It be noted that after five (5) minutes break the Speaker announced that a quorum has assembled;
- 2.9 It be noted that Cllr Morei K requested a caucus which the Speaker granted;

FEEDBACK FROM THE CAUCUS

- That the proceedings of the Special Council of 10th August 2022 proceeds.

3. REPORTS:

- 3.1 It be noted that during the sitting of the Special Council meeting, items 154 -163 and 165 were discussed;


4. **ADOPTION OF MINUTES:**

Minutes of the (12/2022S) *Special* meeting of Council held on **10th August 2022** were approved on **23rd August 2022**.


5. **CLOSURE.**
