





- 1. Bid documents available at a non-refundable amount of R 1 500-00 per bid document are available on the e-tender website and must be downloaded.
- A compulsory briefing session will be held as follows: 26 October 2022 from 09H00 10H30 @ the Missionary Mpheni House, Rustenburg Local Municipality. Cnr Beyers Naude and Nelson Mandela Drive
- 3. Sealed bid documents marked: "RLM/DRT/0026/2022/23 Appointment of one or more service providers for the provision of road marking services as and when required for a period of 36 months" must be placed in the bid box in the foyer of the Municipal offices, Missionary Mpheni House, Beyers Naude Drive, Rustenburg not later than 29th November 2022 @ 11H00, where after the bids will be opened in public at the Municipal offices.
- 4. The bid will be evaluated as follows: Administrative evaluation (document completion and attachment of mandatory documents), LDV with mounted Machine with 2 x Spray Gun, Mounted road-marking machine, CIDB Grading 3SK or higher, 80/20 preferential point system (price = 80 & BBBEE points = 20) and Consideration of the market analysis
 - 5. Please note that no bid documents given to couriers will not be signed for by Rustenburg Local Municipality.
 - 6. The Council will not be responsible for bids not received or received late by mail. Bids will remain valid for 90 days (Ninety).
 - 7. All bids will be adjudicated based on the prescribed criterion as stipulated in the document.
 - 8. An updated record of payment of rates, taxes and services to the relevant Municipality must be attached. Failure to do so will invalidate the bid submitted




T1.2 Tender Data



F.1.3.2 Replace the contents of the clause with the following:

The Standard Conditions of Tender, the Tender Data, List of Returnable Documents and Returnable Schedules which are required for the tender evaluation purposes, shall form part of the Contract arising from the invitation to tender.

F.2.1 Only those tenderers who are registered with the CIDB, or are capable of being so prior to the evaluation of submissions, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a GB class of construction work, are eligible to submit tenders.

Joint ventures are eligible to submit tenders provided that:

- 1. Every member of the joint venture is registered with the CIDB;
- 2. The lead partner has a contractor grading designation in the GB class of construction work; and the combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a GB class of construction work.

Tenderers faced with the above scenario and who fail to meet the combined designation grading will not be considered for the tender.

F.2.2 Add the following to the clause:

Accept that the Employer will not compensate the tenderer for any costs incurred in attending interviews in the office of the employer or the employer's agent (if required).

F.2.7 The arrangements for an official clarification meeting are as stated in the Tender Notice and Invitation to Tender.


Tenderers must sign the attendance list in the name of the tendering entity. Addenda will be issued to and tenders will be received only from those tendering entities appearing on the attendance list.

F.2.10.5 Add the following to the clause:

A digital copy of the Bill of Quantities can be obtained from the emails provided on the advert at the Rustenburg Local Municipality office upon sufficient notice.

F.2.11 Add the following to the clause:

To correct errors made, draw a line through the incorrect entry and write the correct entry above in black ink and place the full signatures of the authorised signatories next to the correct entry.

Calculations must be set out in a clear and logical sequence and must clearly reflect all design assumptions. Pricing Data must reflect all assumptions in the development of the pricing proposal.

Acceptance of an alternative tender offer will mean acceptance in principle of the offer. It will be an obligation of the contract for the tenderer, in the event that the alternative is accepted, to accept full responsibility and liability that the alternative offer complies in all respects with the Employer's standards and requirements.

The modified Pricing Data must include an amount equal to 5% of the amount tendered for the alternative offer to cover the Employer's costs of confirming the acceptability of the detailed design before it is constructed.

F.2.13 Add the following to the clause:

No claim will be entertained for faults in the tender price resulting from any discrepancies, omissions or indistinct figures.

F.2.13.2 Replace the contents of the clause with the following:

Return all volumes of the tender document to the Employer after completion of the relevant sections of each volume in their entirety, either electronically (if they were issued in electronic format) or by writing in black ink.



F.2.14 Add the following to the clause:

The Tenderer is required to enter information in the following sections of the document:


The above sections shall be signed by the Tenderer (and witnesses where required). Individual pages should only be initialled by the successful Tenderer and by the witnesses after acceptance by the Employer of the Tender Offer.

The Tenderer shall complete and sign the Form of Offer prior to the submission of a Tender Offer.

The Schedule of Deviations (if applicable) shall be signed by the successful Tenderer after acceptance by the Employer of the Tender Offer.


Accept that the Employer or his agent, reserves the right to approach the Tenderer's banker or guarantor(s) as indicated in the tender document, or the bankers of each of the individual members of any joint venture that is constituted for purposes of this Contract, with a view to ascertaining whether the required guarantee will be furnished, and for purposes of ascertaining the financial strength of the Tenderer or of the individual member of such venture.

- F.2.22 Return all retained tender documents prior to the closing time for the submission of Tender Offers.



F.1 General

F.1.1 Actions

F.1.1.1 The employer and each tenderer submitting a tender offer shall comply with these conditions of tender. In their dealings with each other, they shall discharge their duties and obligations as set out in F.2 and F.3, timeously and with integrity, and behave equitably, honestly and transparently, comply with all legal obligations and not engage in anticompetitive practices.

F.1.1.2 The employer and the tenderer and all their agents and employees involved in the tender process shall avoid conflicts of interest and where a conflict of interest is perceived or known, declare any such conflict of interest, indicating the nature of such conflict. Tenderers shall declare any potential conflict of interest in their tender submissions. Employees, agents and advisors of the employer shall declare any conflict of interest to whoever is responsible for overseeing the procurement process at the start of any deliberations relating to the procurement process or as soon as they become aware of such conflict, and abstain from any decisions where such conflict exists or recuse themselves from the procurement process, as appropriate.

- Note: 1) A conflict of interest may arise due to a conflict of roles which might provide an incentive for improper acts in some circumstances. A conflict of interest can create an appearance of impropriety that can undermine confidence in the ability of that person to act properly in his or her position even if no improper acts result.
 - 2) Conflicts of interest in respect of those engaged in the procurement process include direct, indirect or family interests in the tender or outcome of the procurement process and any personal bias, inclination, obligation, allegiance or loyalty which would in any way affect any decisions taken.

F.1.1.3 The employer shall not seek and a tenderer shall not submit a tender without having a firm intention and the capacity to proceed with the contract.

F.1.2 Tender Documents

The documents issued by the employer for the purpose of a tender offer are listed in the tender data.

F.1.3 Interpretation

a)

F.1.3.1 The tender data and additional requirements contained in the tender schedules that are included in the returnable documents are deemed to be part of these conditions of tender.


F.1.3.2 These conditions of tender, the tender data and tender schedules which are only required for tender evaluation purposes, shall not form part of any contract arising from the invitation to tender.

F.1.3.3 For the purposes of these conditions of tender, the following definitions apply:

Conflict of interest means any situation in which:

i) someone in a position of trust has competing professional or personal interests which make it difficult to fulfil his or her duties impartially;

ii) an individual or organization is in a position to exploit a professional or official capacity in some way for their personal or corporate benefit; or





iii) incompatibility or contradictory interests exist between an employee and the organization which employs that employee.

- b) **comparative offer** means the tenderer's financial offer after all tendered parameters that will affect the value of the financial offer have been taken into consideration in order to enable comparisons to be made between offers on a comparative basis
- c) **corrupt practice** means the offering, giving, receiving or soliciting of anything of value to influence the action of the employer or his staff or agents in the tender process; and
- d) fraudulent practice means the misrepresentation of the facts in order to influence the tender process or the award of a contract arising from a tender offer to the detriment of the employer, including collusive practices intended to establish prices at artificial levels
- e) **organization** means a company, firm, enterprise, association or other legal entity, whether incorporated or not, or a public body
- f) **quality** (functionality) means the totality of features and characteristics of a product or service that bear on its ability to satisfy stated or implied needs

F.1.4 Communication and employer's agent

Each communication between the employer and a tenderer shall be to or from the employer's agent only, and in a form that can be readily read, copied and recorded. Communications shall be in the English language. The employer shall not take any responsibility for non-receipt of communications from or by a tenderer. The name and contact details of the employer's agent are stated in the tender data.

F.1.5 The employer's right to accept or reject any tender offer

F.1.5.1 The employer may accept or reject any variation, deviation, tender offer, or alternative tender offer, and may cancel the tender process and reject all tender offers at any time before the formation of a contract. The employer shall not accept or incur any liability to a tenderer for such cancellation and rejection but will give written reasons for such action upon written request to do so.

F.1.5.2 The employer may not subsequent to the cancellation or abandonment of a tender process or the rejection of all responsive tender offers reissue a tender covering substantially the same scope of work within a period of six months unless only one tender was received and such tender was returned unopened to the tenderer.

F.1.6 Procurement procedures

F.1.6.1 General

Unless otherwise stated in the tender data, a contract will, subject to F.3.13, be concluded with the tenderer who in terms of F.3.11 is the highest ranked or the tenderer scoring the highest number of tender evaluation points, as relevant, based on the tender submissions that are received at the closing time for tenders.

F.1.6.2 Competitive negotiation procedure

F.1.6.2.1 Where the tender data require that the competitive negotiation procedure is to be followed, tenderers shall submit tender offers in response to the proposed contract in the first round of submissions. Notwithstanding the requirements of F.3.4,





the employer shall announce only the names of the tenderers who make a submission. The requirements of F.3.8 relating to the material deviations or qualifications which affect the competitive position of tenderers shall not apply.

F.1.6.2.2 All responsive tenderers, or not less than three responsive tenderers that are highest ranked in terms of the evaluation method and evaluation criteria stated in the tender data, shall be invited in each round to enter into competitive negotiations, based on the principle of equal treatment and keeping confidential the proposed solutions and associated information. Notwithstanding the provisions of F.2.17, the employer may request that tenders be clarified, specified and fine-tuned in order to improve a tenderer's competitive position provided that such clarification, specification, fine tuning or additional information does not alter any fundamental aspects of the offers or impose substantial new requirements which restrict or distort competition or have a discriminatory effect.

F.1.6.2.3 At the conclusion of each round of negotiations, tenderers shall be invited by the employer to make a fresh tender offer, based on the same evaluation criteria, with or without adjusted weightings. Tenderers shall be advised when they are to submit their best and final offer.

F.1.6.2.4 The contract shall be awarded in accordance with the provisions of F.3.11 and F.3.13 after tenderers have been requested to submit their best and final offer.

F.1.6.3 Proposal procedure using the two stage system

F.1.6.3.1 Option 1

Tenderers shall in the first stage submit technical proposals and, if required, cost parameters around which a contract may be negotiated. The employer shall evaluate each responsive submission in terms of the method of evaluation stated in the tender data, and in the second stage negotiate a contract with the tenderer scoring the highest number of evaluation points and award the contract in terms of these conditions of tender.

F.1.6.3.2 Option 2

F.1.6.3.2.1 Tenderers shall submit in the first stage only technical proposals. The employer shall invite all responsive tenderers to submit tender offers in the second stage, following the issuing of procurement documents.

F.1.6.3.2.2 The employer shall evaluate tenders received during the second stage in terms of the method of evaluation stated in the tender data, and award the contract in terms of these conditions of tender.


F.2 Tenderer's obligations

F.2.1 Eligibility

F.2.1.1 Submit a tender offer only if the tenderer satisfies the criteria stated in the tender data and the tenderer, or any of his principals, is not under any restriction to do business with employer.

F.2.1.2 Notify the employer of any proposed material change in the capabilities or formation of the tendering entity (or both) or any other criteria which formed part of the qualifying requirements used by the employer as the basis in a prior process to invite the tenderer to submit a tender offer and obtain the employer's written approval to do so prior to the closing time for tenders.

F.2.2 Cost of tendering

Accept that, unless otherwise stated in the tender data, the employer will not compensate the tenderer for any costs incurred in the preparation and submission of a tender offer, including the costs of any testing necessary to demonstrate that aspects of the offer complies with requirements.

F.2.3 Check documents

Check the tender documents on receipt for completeness and notify the employer of any discrepancy or omission.

F.2.4 Confidentiality and copyright of documents

Treat as confidential all matters arising in connection with the tender. Use and copy the documents issued by the employer only for the purpose of preparing and submitting a tender offer in response to the invitation.

F.2.5 Reference documents

Obtain, as necessary for submitting a tender offer, copies of the latest versions of standards, specifications, conditions of contract and other publications, which are not attached but which are incorporated into the tender documents by reference.

F.2.6 Acknowledge addenda

Acknowledge receipt of addenda to the tender documents, which the employer may issue, and if necessary apply for an extension to the closing time stated in the tender data, in order to take the addenda into account.

F.2.7 Clarification meeting

Attend, where required, a clarification meeting at which tenderers may familiarize themselves with aspects of the proposed work, services or supply and raise questions. Details of the meeting(s) are stated in the tender data.

F.2.8 Seek clarification

Request clarification of the tender documents, if necessary, by notifying the employer at least five working days before the closing time stated in the tender data.

F.2.9 Insurance

Be aware that the extent of insurance to be provided by the employer (if any) might not be for the full cover required in terms of the conditions of contract identified in the contract data. The tenderer is advised to seek qualified advice regarding insurance.

F.2.10 Pricing the tender offer

F.2.10.1 Include in the rates, prices, and the tendered total of the prices (if any) all duties, taxes (except Value Added Tax (VAT), and other levies payable by the successful tenderer, such duties, taxes and levies being those applicable 14 days before the closing time stated in the tender data.

F.2.10.4 State the rates and prices in Rand unless instructed otherwise in the tender data. The conditions of contract identified in the contract data may provide for part payment in other currencies.

F.2.12 Alternative tender offers

F.2.12.1 Unless otherwise stated in the tender data, submit alternative tender offers only if a main tender offer, strictly in accordance with all the requirements of the tender documents, is also submitted as well as a schedule that compares the requirements of the tender documents with the alternative requirements that are proposed.

F.2.12.2 Accept that an alternative tender offer may be based only on the criteria stated in the tender data or criteria otherwise acceptable to the employer.

F.2.13.3 Submit the parts of the tender offer communicated on paper as an original plus the number of copies stated in the tender data, with an English translation of any documentation in a language other than English, and the parts communicated electronically in the same format as they were issued by the employer.

F.2.13.4 Sign the original and all copies of the tender offer where required in terms of the tender data. The employer will hold all authorized signatories liable on behalf of the tenderer. Signatories for tenderers proposing to contract as joint ventures shall state which of the signatories is the lead partner whom the employer shall hold liable for the purpose of the tender offer.

F.2.13.5 Seal the original and each copy of the tender offer as separate packages marking the packages as "ORIGINAL" and "COPY". Each package shall state on the outside the employer's address and identification details stated in the tender data, as well as the tenderer's name and contact address.

Accept that tender offers, which do not provide all the data or information requested completely and in the form required, may be regarded by the employer as nonresponsive.

F.2.15 Closing time

F.2.15.1 Ensure that the employer receives the tender offer at the address specified in the tender data not later than the closing time stated in the tender data. Accept that proof of posting shall not be accepted as proof of delivery.

F.2.15.2 Accept that, if the employer extends the closing time stated in the tender data for any reason, the requirements of these conditions of tender apply equally to the extended deadline.

F.2.16 Tender offer validity

F.2.16.1 Hold the tender offer(s) valid for acceptance by the employer at any time during the validity period stated in the tender data after the closing time stated in the tender data.

F.2.16.2 If requested by the employer, consider extending the validity period stated in the tender data for an agreed additional period with or without any conditions attached to such extension.

F.2.16.3 Accept that a tender submission that has been submitted to the employer may only be withdrawn or substituted by giving the employer's agent written notice before the closing time for tenders that a tender is to be withdrawn or substituted.

F.2.16.4 Where a tender submission is to be substituted, submit a substitute tender in accordance with the requirements of F.2.13 with the packages clearly marked as "SUBSTITUTE".

F.2.17 Clarification of tender offer after submission

Provide clarification of a tender offer in response to a request to do so from the employer during the evaluation of tender offers. This may include providing a breakdown of rates or prices and correction of arithmetical errors by the adjustment of certain rates or item prices (or both). No change in the competitive position of tenderers or substance of the tender offer is sought, offered, or permitted.

Note: Sub-clause F.2.17 does not preclude the negotiation of the final terms of the contract with a preferred tenderer following a competitive selection process, should the Employer elect to do so.

F.2.18 Provide other material

F.2.18.1 Provide, on request by the employer, any other material that has a bearing on the tender offer, the tenderer's commercial position (including notarized joint venture agreements), preferencing arrangements, or samples of materials, considered necessary by the employer for the purpose of a full and fair risk assessment. F.2.20 Submit securities, bonds, policies, etc.

C3 Scope of Work

The painting of road markings in the Rustenburg Local municipality area on an "as and when" required basis for the period 30 November 2022 to 30 November 2025.

The municipality's project manager shall prepare a schedule of quantities for each project, and apply the rates tendered by the successful tenderer for the relevant work area.

Taking into consideration that the projects are all maintenance related, no indication can be given as to the size and number of the projects.

1. TARIFFS MUST BE ALL-INCLUSIVE

The Contractor must accept the payment provided for in the contract and which is represented by the tariffs in his tender, as full payment for the execution and completion of the work as specified; for obtaining, supplying, placement and installation of all materials; for obtaining and supplying labour, supervision, overheads, machinery, tools and construction equipment; for surplus material, transport, on and off loading, handling, maintenance, temporary work, tests, quality control including necessary to complete the work, all in accordance with the specifications

2. ESTABLISHMENT

2.1. The successful contractor will be required to establish on site within 14 days of the date of an official order placed, failing which a penalty of R1000/day will apply for each day in breach.

2.2. The contractor will be compensated at the tendered rate for each time he is required to provide the services within the Rustenburg Local Municipality area.

3. TENDER OFFER VALIDITY

The tender offer validity period is 90 days.

4. TENDER EVALUATION

The quantities in the pricing schedule are for a fictitious project and are used only for tender evaluation purposes. Following appointment of the successful tenderer, the tendered rates will be used for the pricing of each project

5. SUBCONTRACT

As per Rustenburg Local Municipality Local Development Policies and Procedures.

6. TENDER PERIOD

The tender period shall be from 30 November 2022 to 30 November 2025

7. ESCALATION

Escalation of 6% per annum will be applicable as from the 2nd and 3rd year. Note that year one stays fixed.

8. PENALTIES

The contract period for each project will be determined and agreed upon by the municipality in consultation with the contractor. A penalty of R 250 per day for late completion will be deductible from any monies due.


9. CLARIFICATION MEETING

A compulsory site clarification meeting must be attended by prospective tenderers, failing which the tender will not be considered.

10. ACCOMMODATION OF TRAFFIC

10.1. It is a condition of this contract that traffic is accommodated taking into account the provisions of the latest edition of the South African Road Traffic Signs Manual (SARTSM). The contractor will be held responsible for all site safety and must take all necessary steps to ensure his own worker's and the public's safety while applying the road markings

10.2. Warning signage shall be in accordance with the South African Road Traffic Sign Manuals and any other applicable legislation for the painting of road markings. Failing to comply will result in a penalty of R5,000 per occurrence being applied.



11. STANDARDS FOR CONSTRUCTION WORKS

The COLTO Standard Specification for Roads and Bridge Works for State Road Authorities 1998 as well as the GCC 2004 and any amendments thereto, will apply.

11.1. SURFACE PREPARATION

Care must be taken to ensure that the voids in open grade asphalt are free of moisture. The onus is on the contractor to ensure that the surface on which the road markings are to be applied are sufficiently clean and dry to ensure that the quality of the road markings will not be adversely affected.

11.2. Applying the paint

11.2.1. The Plastiliner type plastic methyl methacrylate(MMA) retro reflective road marking paint shall be applied at the rate of 0,42l/m² No deviation below the application rate of 0,42l/m² will be accepted. If the Engineer should discover that the application is not being done according to this specification, the Contractor will repaint the sections concerned with a new layer of paint at the rate of 0,42l/m², at no extra cost to the municipality. No extra payment shall be made for applications above the specified rate

11.2.2. The mobile spraying machine shall be adjustable to cater for variable line widths up to 200mm, be capable of applying lines under traffic without causing unnecessary traffic build-up behind the machine.

11.3. Tolerances

11.3.1. When a continuous line and an intermittent line are painted next to each other, the beginnings and/or ends of the adjoining lines must coincide

11.3.2. When existing works are painted over, the new marks may not deviate more than 50 mm over the length and 5 mm over the breadth of the existing marking

11.4. Materials

11.4.1. Plastiliner type plastic methyl methacrylate(MMA) retro reflective Road-marking paint shall comply with the requirements of SANS 731-1 for Type 1 (retro-reflective) being road-marking paint for machine spray applications, with a non-pick-up time of Class 1 (15 minutes' maximum) The paint shall be delivered on site in sealed containers, marked in accordance with SANS 731-1

11.

12. COMPLIANCE WITH OCCUPATIONAL HEALTH AND SAFETY ACT 1993

12.1. Tenderers are to note the requirements of the Occupational Health and Safety Act No. 85 of 1993 and the Construction Regulations 2012 and any amendments thereto, issued in terms of Section 43 of the Act. The tenderer shall be deemed to have read and fully understood the requirements of the above Act and Regulations and to have allowed for all costs in compliance therewith.

12.2. In this regard the Tenderer shall submit with his tender, a detailed Health and Safety Plan in respect of the Works in order to demonstrate the necessary competencies and resources to perform the construction work all in accordance with the Act and Regulations. The Health and Safety Plan shall cover inter-alia the following details:


12.2.1. The safety management structure including the names of all designated persons such as the construction supervisor and any other competent persons;

12.2.2. Safety method statements and procedures to be adopted to ensure compliance with the OHS Act.

12.2.3. Aspects to be dealt with shall include:

- 12.2.3.1. Public vehicular and pedestrian traffic accommodation measures;
- 12.2.3.2. Control of the movement of construction vehicles;
- 12.2.3.3. The storage and use of materials;
- 12.2.3.4. The use of tools, vehicles and plant;

- 12.2.3.5. Temporary support structures;
- 12.2.3.6. Security, access control and the exclusion of unauthorized persons.
- 12.2.3.7. Compliance with way leaves, permissions and permits;
- 12.2.3.8. Safety equipment, devices and clothing to be employed;
- 12.2.3.9. Emergency procedures;
- 12.2.3.10. Provision of welfare facilities;
- 12.2.3.11. Induction and training;
- 12.2.3.12. Provision a n d maintenance o f the health and safety file and other documentation;

12.2.3.13. Arrangements for monitoring and control to ensure compliance with the safety plan.


12.3. The Contractor shall prepare and maintain a Health and Safety File in respect of the project, which shall be available for inspection on Site at all times.

12.4. The Contractor is required to submit to the Employer the Occupational Health and Safety Agreement and a letter of good standing from the Compensation Commissioner.

13. VEHICLES, PLANT and EQUIPMENT

13.1. The Tenderer must have a self-propelled mobile spraying machine available for this tender, failing which the tender will not be evaluated further.
